The added money and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 122 lbs. Non-winners of \$30,000 allowed 2 lbs.; two races, 4 lbs.; a race at a mile or over, 6 lbs. (Maiden and claiming races not considered in allowances). Starters to be named at the closing time of entries. A trophy will be presented to the winning owner.
