

**NYRA Belmont Stakes Sweepstakes**  
**OFFICIAL RULES**  
**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**ELIGIBILITY:** Open to legal residents of the continental United States, 18 or older. Employees of The New York Racing Association, Inc. ("Sponsor"), NYRAbets, LLC ("NYRA Bets"), and their respective parents, subsidiaries, affiliates, advertising agents and promotional partners, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, of such individuals are not eligible to enter or win.
